AN INSPECTION BY THE TOWN OF GORHAM IS REQUIRED PRIOR TO THE PLACEMENT OF ANY TRENCH BACKFILL. ONCE THE DRIVEWAY/CULVERT IS INSTALLED PER APPROVAL – CALL PUBLIC WORKS 892-9062 FOR AN INSPECTION

NOTE:	1. FOR INSPECTION PURPOSES: The proposed driveway location must be clearly marked with stakes.
	2. The culvert should be smooth-bore HDPE or approved equivalent. The minimum culvert size is 15 inches inside diameter by 30 feet in length.
	3. The minimum depth of gravel over the culvert is 12 inches.
	4. A driveway apron must be paved with 4 inches of bituminous concrete. The paved apron will extend from the edge of the existing roadway edge and will extend to the limit of the public right of way. Paved aprons will be a minimum of 12 feet in width having five (5) foot radii, minimum.
	DRIVEWAYS CONSTRUCTED IN WINTER MONTHS REQUIRE A \$1,500.00 CASH PAVED APRON PERFORMANCE GUARANTEE TO BE ESTABLISHED WITH GORHAM PUBLIC WORKS. ONCE PAVED APRON HAS BEEN INSTALLED THE PERFORMANCE GUARANTEE WILL BE REFUNDED.

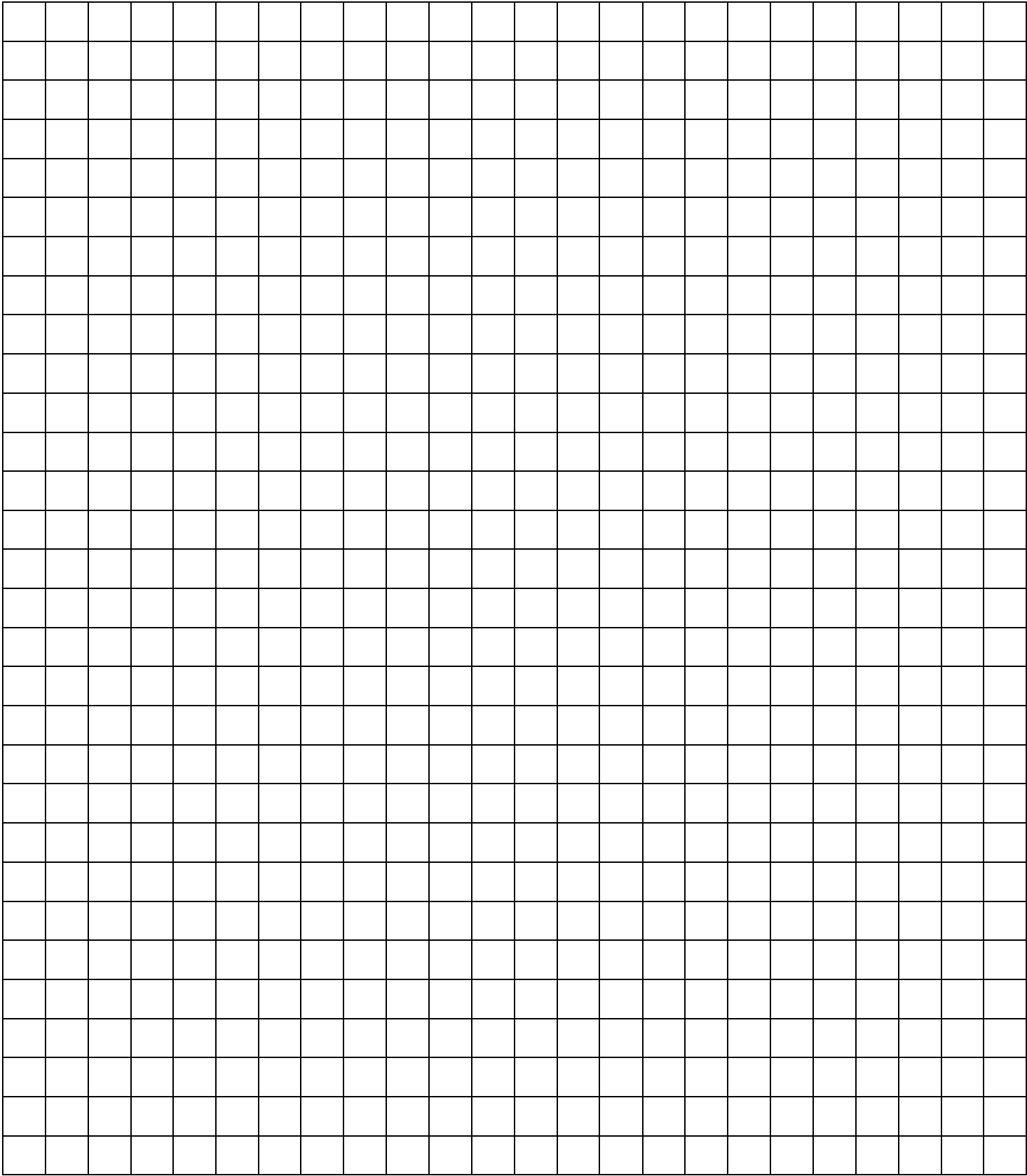
