A certain lot or parcel of land in said Gorham bounded and described as follows:

Beginning at a point marking the northwesterly corner of the land conveyed by Jessie A. McLellan to Mary J. Morse, October 6, 1941, recorded in the Cumberland County Registry of Deeds in Book 1655, Page 264, which said land is a second parcel described in a deed from Kenneth H.
